# 4. FIRST AID MEASURES

# First-aid measures

Inhalation

: Move exposed person to fresh air. Keep person warm and at rest. #### Ingestion

# 6. ACCIDENTAL RELEASE MEASURES

#### **Environmental precautions**

# Methods for cleaning up Small spill
